Boeing 747 Dreamlifter Gets Certified

Boeing's 747 Dreamlifter - the modified 747-400 used to transport the major assemblies of the Boeing 787 Dreamliner - was awarded type certification from the FAA (Federal Aviation Administration). This certification proves that the Dreamlifter has passed all of the strict testing and safety requirements from the FAA, and does not require any further testing or certification. This is a huge step for Boeing and its place in the aviation industry.

The FAA had officials fly on board the aircraft as it delivered parts of the Dreamline r around the world. This



enabled administrators to evaluate the delivery process and overall operations - the Dreamlifter is only certified to carry essential crew and parts for delivery - it is not a passenger aircraft.

"This certification reflects not only the safety and reliability of the Dreamlifter but also its remarkable performance," reports Scott Strode, 787 vice president of Airplane Definition and Production.

It official! There are 50,000 metric tons (m/t) of halon 1301 remaining in the world and 90,000 m/t of halon 1211. (That would be 110,000,000 lbs and 198,000,000 lbs for the metrically challenged.) That's the word from the Halon Technical Options Committee (HTOC) 2006 report to the UNEP, which reports on the worldwide status of compliance with the Montreal Protocol on Substances that deplete the ozone layer. You can link to the report here.

These numbers reflect an 11,000 m/t increase in halon 1301 and a 15,000 m/t decrease in halon 1211 compared to the committee's 2002 report. This difference, says the committee, was caused by modeling and estimated emission errors in earlier reports.

If you believe these numbers and are in, say, the commercial aviation industry, calculations will show that you have approximately, a 275 year inventory available. But since we are "Doubting Thomases" when it comes to the *modeling* of 30 year old production data and measuring atmospheric emissions of halons at 30,000 feet over Dublin, let's take that number and cut it in half. That leaves about 137 years of halon available. Anyone worried about running out of halon yet?

But what if the numbers are wrong? What if they're not 50% overstated but 75% overstated?! Well, that would leave us with 12,500 m/t and enough halon 1301 for commercial aviation for the next 69 years. Worried yet? We didn't think so.

So why the rush to move away from halon – especially in commercial aviation? The HTOC report states (almost in an alarming manner) "Given the anticipated 25-30 year lifespan of civil aircraft, this dependency (on halons) is likely to continue well beyond the time when existing halon stocks expire." They even talk of aircraft being grounded! Well, not if HTOC believes their own inventory numbers, they won't be! They go on to cite an "Action Plan" to help nudge the commercial aviation industry away from halons.

It seems to us that until someone comes up with an inexpensive and environmentally responsible way to destroy halon and figures out a way to pay for it, the best thing we can do for the environment is...wait for it...

Nothing.

Well, not exactly nothing. From what we see, the commercial aviation sector is moving forward in a planned and determined fashion, and committing resources to come up with a viable replacement. Our guess is that this will happen without a nudge from HTOC.

In the meantime there is plenty of halon available and pulling the plug on halon going into commercial aviation

Airbus & Interjet

The Mexican airline Interjet has taken its first delivery of the A320 from Airbus!

Interjet began operations in December 2005, by gathering 7 pre-owned A320's from Europe. Interjet has grown concurrently with its need for more A320s; it has a total of 20 to date. The brand new A320 that interjet has acquired will accomodate 150 passengers comfortably - no first or coach class, either. The cabin of the A320 is the new modern and bright design, and the aircraft is equipped with CFM56-5B4/P engines from CFV International. The A320 will be added to Interjet's domestic flight service operating out of the Toluca Airport.

"The A320 is without a doubt the reference in the low cost market. It ideally combines unmatched operating costs with the highest level of passenger comfort," reports Miguel Aleman, Chairman of Interjet. "It allows us to operate the low fares and high efficiency...whilst preserving the highest standards of service quality."

Triple Raspberry Brownies

Ingredients:

1/2 cup moist prunes (recommended: Sunsweet)(note: I had problems finding moist prunes without pits. It's not too tough to de-pit a prune if you can't find any pitless; just kind of smoosh it on a paper plate with a spoon and the pit pops out!)

1/3 cup unsweetened organic applesauce (recommended: Santa Cruz)

1 (19.5-ounce) box brownie mix (recommended: Betty Crocker)

2 egg whites

1/4 cup raspberry liqueur or water (note: I used Light Cranberry Raspberry Juice Cocktail and it worked fine!) 1/3 cup 100 percent raspberry fruit spread or preserves

For the raspberry sauce:

2 cups frozen raspberries, thawed (recommended: Dole)

1 tablespoon honey

2 tablespoons raspberry liqueur (same thing here, too, with the juice!)

Fresh raspberries, for garnish Fresh mint sprigs, for garnish

For the brownies:

Preheat oven to 350 degrees F. Lightly spray a 9 by 9-inch baking pan with butter flavored cooking spray; set aside.

In a blender, puree prunes and applesauce. Transfer to $\hat{\epsilon}$ medium mixing bowl.

Add brownie mix, egg whites, and raspberry liqueur or water to blender. Blend just to combine. Transfer to prepared baking pan; set aside.

In a small saucepan over medium-high heat, melt the preserves. Drizzle over brownies. Swirl with a table knife

Bake in preheated oven for 30 to 35 minutes. Remove and cool completely before cutting.

For the raspberry sauce:

Puree thawed raspberries, honey, and brandy in blender Push through a fine mesh strainer; set aside.

To serve, spoon 1 to 2 tablespoons coulis on a plate. Place brownie in center of coulis. Garnish with 3 to 5 fresh raspberries and a fresh mint sprig.
