Having read the Waxman Bill – or relevant parts of it – twice, two things are certain: one is that HFC's (FM200 among them) will be subject to a production phased down (probably over decades); and, HFC's will, on one form or another be taxed. We've reported on this and nothing more and would like to think that the Halon Herald has played a role in focusing the fire protection industry's attention on the impact of this legislation and how to deal with quest

ions arising in the field. The FSSA's recently released report on current HFC legislation under consideration (reported elsewhere on these pages) takes a big step in the right direction.

So does DuPont's Webinar on HFC Sustainability, which we attended earlier today. DuPont's Ken Blanchard and Mac McFarland did a great job of explaining the potential impact of the Waxman bill.

Some in the industry think this is a pretty serious matter. Others have "shrugged" and suggested that we simply adjust to changing reality. We are not sure where this matter falls on the crisis chart. We're inclined to think it is way short of the halon crisis of the early 1990's. We are sure that the issue will require a sustained communication with the fire protection distributor in order to prevent a market shrinkage caused by market confusion. The actions taken this week by the FSSA and DuPont were a step in the right direction.

Tech Tips

Tech Tip by George McDonald & Mark Buser

This month's tech tip, presented by George and Mark in our warehouse, has to do with pressurizing a cylinder so that the gauge is in that all important "green area".

When presurizing a newly repaired/refilled tank, one must remember to allow for "absorbtion". In absorbtion, the nitrogen in the tank will mix with the inside agent - whether it's halon, FM-200, or any other clean agent. If the tank is not shaken or vibrated after filling and repairing, the arrow on the gauge may slip back, leading one to believe there is a leak or under pressurization.

In this situation, it is likely that all is ok in reality, however, the misreading of the gauge will be cause for alarm, and cause issues in future gauge readings where there actually might be a real problem. So, the "shake & bake" and over compensating with the nitro addition ,is the way to go, to keep the arrow in the green!

Recipe of the Month

Bobby Flay's Nacho Dogs

Umm, hello...hot dogs meets nachos? That equals love in this editor-in-chief's heart. I love nachos...I love hot dogs...add some guacamole and you've got my culinary version of Romeo and Juliet. Don't let the lengthy

ingredients and prep list fool you - this meal is easier than it looks.

This recipe was found here, on Food Network's website.

Ingredients

For the guacamole:

- * 2 ripe Hass avocados, peeled, pitted and coarsely chopped
- * 1 large jalapeno, finely diced
- * 3 tablespoons finely diced red onion
- * 1 lime, juiced
- * 2 tablespoons canola oil
- * 3 tablespoons chopped fresh cilantro leaves
- * Salt
- * Freshly ground black pepper

For the grilled tomato-chipotle salsa:

- * 4 plum tomatoes
- * 4 tablespoons canola oil
- * Sal
- * Freshly ground black pepper
- * 3 tablespoons red wine vinegar
- * 2 teaspoons chipotle in adobo puree

For the hot dogs:

- * 8 kosher beef, turkey or chicken hot dogs
- * 8 hot dog buns, split 3/4 of the way through
- * 1 1/2 cups grated white Cheddar
- * 8 pickled jalapenos, thinly sliced
- * Fried blue corn tortilla chips, coarsely crumbled

For the guacamole:

Directions

Combine the avocados, jalapeno, onion, lime juice, oil and cilantro in a bowl and gently mix until combined. Season with salt and pepper.

For the grilled tomato-chipotle salsa:

Heat the grill to high. Brush tomatoes with 2 tablespoons of the canola oil and season with salt and pepper. Place on the grill until charred on all sides. Remove from the grill, slice the tomatoes in half, remove the seeds and coarsely chop. Whisk together the remaining 2 tablespoons of oil, vinegar and chipotle puree in a small bowl, add the tomatoes and stir to combine. Season with salt and pepper.

For the hot dogs:

Heat the grill to high. Grill dogs until golden brown on all sides, about 7 minutes. Remove to a plate. Place buns on the grill cut side down and grill until lightly golden brown, about 20 seconds. Place hot dogs in the buns, top with cheese, jalapeno, guacamole, salsa and tortilla chips.
